- Maximum housing occupancy duration is 3 years for MS/MA and 6 years for PhD students.
- Housing assignments are made only for full-time graduate students who are enrolled in programs with thesis.
- The following reduction will be applied in the monthly fees listed above for full-time students who have full tuition scholarship: 50% for PhD and 25% for MS/MA students.
- Housing applications of married students will be evaluated separately depending on availability. A copy of the marriage certificate must be submitted with the application.
- All graduate students residing in dormitory/apartments are required to comply with the Bilkent University Dormitory/Housing Rules and Regulations.
- When necessary, Rectorate Office is entitled to ask for an evacuation or a change of the dormitory/housing unit.
- In all housing changes, a housing change fee will be charged.
- Monthly housing fees listed above will be deducted from the monthly stipends each month. If the monthly housing fee exceeds the scholarship amount, the remaining amount can be paid by credit card through STARS. A 5% penalty will be applied to monthly fees that are not paid by the 15th of each month, and Grease payments for students who have outstanding housing fees will be suspended until the balance is paid.
